

Wealden College Certificate and Diploma in Supervision

Course Director: John Baxendale, MSc, PTSTA, CTA, EMDR Europe Accredited, Licence ès lettres, UKCP Registered Psychotherapist and Supervisor.

This Wednesday course aims to provide participants with a comprehensive introduction to the role of supervisor in the caring professions. The course will be run over 16 days during the academic year, from end of July 2021 to early December 2021. The timings will be 09.30 to 16.30 with the usual breaks, and the course is likely to run online using the Zoom platform.

While particularly designed for supervisors of counsellors and psychotherapists, it is suitable for people who wish to be supervisors of volunteers, social workers, nurses, and others in the caring professions.

A team of trained, qualified and experienced supervisors teaches the course.

One of the most important defining characteristics of the counselling, psychotherapy, and other caring professions is the emphasis that is placed on effective and ethical clinical supervision. While particularly designed for supervisors or potential supervisors of therapists, this course is suitable for people who wish to be supervisors of volunteers, social workers, nurses and others in the caring professions. People from caring professions have also found great value in supervision training as a way of enhancing their professional development and service to their clients and patients and thus we welcome applicants from different fields.

This course is designed to provide a thorough grounding in the skills, knowledge and attitudes required to become a competent and ethical supervisor. Our view is that supervisors require breadth and depth of knowledge, skills and character to embody and model high standards of professional practice.

The length of the course and the requirements for completion reflect the importance and value we place on supervision as an expert, professional role.

The course fee is £600 (plus VAT) for the Certificate, and £1600 (plus VAT) for the Diploma. A

non-refundable deposit of 50% is asked for when you book your place.

Requirements:

- Previous training in the caring professions that they intend to supervise.
- Certificate; Attendance at 6 one day modules.
- Diploma; Attendance at 16 one day modules, including the 6 days of Certificate.
- Completion of a project on supervision.
- Submission of a taped supervision session at the end of the course.
- Receiving ongoing supervision while on the course.
- Background reading.

Assessment criteria:

- Active participation during the course.
- Has the trust and respect of fellow students and tutors (see feedback sheet below).
- Written work and taped supervision as detailed below.
- Tutor feedback on skills during the course.

Written work:

Certificate and Diploma

- 1) Completion of a Learning Journal.
- 2) Background reading.
- 3) A short essay.

Diploma

- 4) A case study of your supervision work including your Philosophy of Supervision, and substantial discussion of the issues presented (maximum 6000 words).
- 5) A segment of a Supervision recording of 10 minutes in length. The recorded work must be consistent with your values, as outlined in your essay, and include:
 - a. Reference to Boundary/Protection/Ethical issues arising in this segment and in your work as a whole with this Supervisee.
 - b. A brief description of the context of the work (Level of Supervisee/number of Supervisee sessions etc)

- c. A postscript answering the following questions: “what I did well on the segment of tape...”, “in hindsight I might have.....”
